Hold Harmless Agreement

In consideration of participation in the Fife Harvest Festival, the vendor hereby assumes all risk of injury, damage and liability, and waive any right of recovery from, or to bring suit against the City for any personal injury, death, or other consequences arising out of vendor's participation in the activity, except for the sole negligence of the City.

The vendor further agrees to indemnify, defend and hold the City of Fife, its officers, officials, employees and volunteers harmless from and against any and all claims, demands, losses, actions or liabilities. This includes costs and all attorney fees and injury or death of any person, or for loss or damage to property, to or by any and all persons or entities. Including, without limitation, their respective agents, licensees or representatives, arising from, resulting from, or connected with, the vendor's participation in this event, except only such injury or damage as shall have been occasioned by the sole negligence of the City.

The vendor authorizes any necessary emergency medical treatment that might be required for those of the vendor's organization or myself in the event of physical injury and/or accident to us/me while participating in this program.
